I hereby request a summer disbursement of my LIFE or Palmetto Fellows scholarship (including an Enhancement scholarship, if eligible). As a South Carolina Life or Palmetto Fellows Scholarship recipient, I certify that:

- I have never been adjudicated delinquent or been convicted or pled guilty or nolo contendere to any felonies and have not been convicted or pled guilty or nolo contendere to any second or subsequent alcohol or drug related misdemeanor offenses under the laws of this or any other state or under the laws of the United States since one year prior to the first day of classes for the upcoming fall semester.
- If my status changes after signing this affidavit but before the beginning of the summer term, I understand and agree that I must and will immediately report my adjudication, conviction, or plea to the Office of Financial Aid and that I may lose eligibility for my state aid.
- I am presently not in default on any federal or state student loans nor do I owe any refunds to any federal or state financial aid programs.
- I provide authorization to have my summer scholarship information made available to institutions for determination of continued eligibility.
- I understand that I must be enrolled in at least 12 credit hours during the summer term(s) in order to receive a summer disbursement of LIFE or Palmetto Fellows. If I fail to enroll in twelve or more credit hours during the summer term(s), I understand that my summer disbursement of LIFE or Palmetto Fellows will be returned to the state, and that I will be held liable for the resulting institutional balance.
- I have read and received (via the North Greenville University website) a copy of the SC Terms and Conditions.
- I understand that acceptance of a summer award disbursement will count against my maximum terms of eligibility and may not lead to early graduation. Furthermore, I understand that any grades/credit hours attempted will be used to determine continued eligibility for LIFE and Palmetto Fellows.
- I understand that LIFE and Palmetto Fellows recipients who met their continued eligibility requirements at the **end of the spring term** may remain eligible for a fall award regardless of their academic performance over the summer.

*Any false information provided by the student or any attempt to expend any scholarship funds for unlawful purposes or any purpose other than in payment or reimbursement for the cost of attendance at the institution authorized to award the scholarship and/or grant will be cause for immediate cancellation. Any student who has obtained a scholarship through means of a willfully false statement or failure to reveal any material fact, condition, or circumstances affecting eligibility will be subject to applicable civil or criminal penalties, including retroactive loss of the scholarship and/or grant.*
